

LEX = Local Extender, REX = Remote Extender


# **Network Connect**

Place the LEX where desired and connect a CAT 5e/6/7 patch cable from the Link port (RJ45) to a network switch or wall network port connected to a switch.




Max 100m between network devices

2 Connect the LEX to the computer using the included USB cable.



Place the REX where desired. Connect a CAT 5e/6/7 patch cable from the Link port (RJ45) to a network switch or wall network port connected to a switch. Connect the REX to the AC adapter and plug it into a power source.



4 Attach the USB device to the REX.




# **Direct Connect**


1 Place extenders where desired and connect the CAT 5e/6/7 extension link cabling to the Link ports (RJ45) on the LEX and REX.




2 Connect the LEX to the computer using the included USB cable.



3 Connect the REX to the AC adapter and plug it into a power source.
