




- 1 Disable Suspend settings on your computer.
 - a. For Windows 7 or 8 open the Control Panel, then select Power Options.




b. For each of the plans listed click on *Change plan settings*.

Then click Change advanced power settings.




d. Expand *USB* settings. Expand *USB* selective suspend setting. Select *Disabled* for all options listed.
